ECI services in Slovakia – TARGET GROUP

Inhabitans – 5,5 million

TARGET GROUP: Children at risk or with developmental disabilities and their families


- 14 000 children and their families
  - 3,5 % of poluation children at risk or with disiability
  - **11,5** % of population family members

## **TOTAL 15 % of population affected**

- Estimation on the base of statistics of
  - Health annual report
  - Education resort Centers of specialized pedagogical counselling
  - WHO estimation

## **ECI services in Slovakia – PRESENT STATE**

- ECI as a social service paid by 8 regional governments methodology mentored Ministry of Social Affairs
  - 3,5 % accessibility
- Rehabilitation services paid by 3 private Health Insurance Companies – methodology mentored by Ministry of Health
  - accessibility very low
- Stimulation and therapies paid by special sources at Ministry of Finance through municipalities methodologically mentored by state institution under Ministry of Education
  - 0,8 % accessibility (2015)



## ECI services in Slovakia – PRESENT STATE

- 1. Liability divided in 4 resorts and many authorities
- 2. Difficult to advocate
- 3. Luck of expersts focused on work with early chilhood
- 4. No unified conception
- 5. Low financial covering
- 6. Substitution of state by the NGO's
- 7. Rehabilitation and therapies paid by families

### ECI services in Slovakia – ECI as a social service LEGISLATION

**CONTENT** In January **2014** Early Childhood Intervention was first time recognized as a social service guaranteed by the social service law as follows:

Early Childhood Intervention services are being provided to children at risk of developmental delay (age 0-7) and their families

ECI services include:

- specialized social counselling in the area of legislation rights, networking
- social rehabilitation support to gain potential in self-service daily routines of the child
- complex developmental stimulation of a child with disability **empowering parents to manage to** stimulate the child in a natural and daily routine based way
- preventive activities to prevent exclusion and family segregation

- community support – coordination of cooperation with other services and nonformal supporting family network

ECI is **PRIMARLY mobile service**, only if necessary can be provided as ambulant service


#### FINANCING

Regional parliaments are OBLIDGED TO PAY ECI SOCIAL SERVICE – since 1.1.2018 COOPERATION

All entities supporting children with disabiliies are obligated to cooperate Providers of ECI under the social sector are obliged to coordinate the cooperation

### ECI services in Slovakia – ECI as a social service - PRINCIPLES


- 1. Partnership between professionals and parents wide support for family (*empowering of families*)
- 2. In-home services are a core principle in offered programs anywhere for free
- 3. Individual family service plan is a key instrument in providing services for clients (strength-based, reflective)
- 4. Transdisciplinary team work team of professionals in different areas
- 5. Building strong relationship btw child and its surrounding
- 6. ECI acts as resource center for families and network of additional services in healthe, education and NGO system
- 7. Transfering the child to next step if possible mainstrem services (inclusive and based in community)
- 8. Staff of ECI is trained in accredited program based on the best available ECI knowledge and practices from last 3 years organized by NASSP




### ECI services in Slovakia – ECI as a social service - TEAM

- 3. 1-2 rarely 3 professions at public providers


**B**ASE TEAM MOSTLY:

- 3. Special pedagogue




ECI services in Slovakia – ECI as a social service PROVIDERS
